Summary from one individual: About 100 people met in Pierce Park - about 50-50 adults and youth. They were also accompanied by Members of the Michigan Chapter of the Lawyers Guild as observers and a team of experienced medics - both local and regional. Marchers started both in M52 and on the sidewalks. A speaker reported that the police said that they would not be blocking traffic for the marchers this week, so the medic cars drove in front and behind the marchers. These cars were stopped by the police and ticketed for obstructing traffic. The process took about 20 minutes and itself blocked traffic much longer than the marchers would have. The marchers continued as before to the Police Station parking lot (their route being blocked once again by another police car). Five police cars were out, one officer on a motorcycle and several on foot. The Chief was in an unmarked car. A full-size fire engine was parked on a side street by the group. There was an open mic and multiple speakers participated. Mark VanderWege introduced himself to the group as running as a write-in candidate for School Board. Two individuals - one in a police uniform and one in plain clothes were on the Police Station roof taking pictures of the group peacefully assembled, sitting and listening to the speakers. Some of the group were drawing with chalk. About 3/4 of the way through the public mic, a group of adult protesters approached Chief Toth sitting in an unmarked car and asked him to come listen. He did. He did not speak to the group but repeated to individuals that he was just doing his job. As the group left to return to the park, a local medic stepped in front of a car that was traveling south on M52 and would have been very close to the group. The car braked quickly and the medic was given a ticket for obstructing traffic. The tickets are misdemeanors that will be fought in court. If upheld, there will be fines to pay and the universal sentiment was that funds would be raised to pay those fines
